- a. Emergency Hotlines (Division and School Level)
- b. Social Media and Text Messaging Services
- c. Walk-in and Legal Assistance (If Applicable)
- 4. In adherence to Equal Opportunity Policy (EOP), inclusive and fair treatment shall be accorded to all concerned/participants regardless of disability, sexual orientation, gender, age, religion and ethnicity.
