## MAXIMIZATION OF CONTACT TIME IN TEACHING AND LEARNING

- 1. Relative to Regional Memorandum No. 653, s. 2022, RE: Maximization of Contact Time in Teaching and Learning, the field is directed to follow the provision stipulated in DM No. 034, s. 2022.
- 2. This reiterates and emphasizes that, "the number of school days shall solely be dedicated to academics and related co-curricular activities. The conduct of extracurricular activities shall be strictly prohibited."
- 3. Guided by these provisions, school must maximize their contact time in teaching and learning with emphasis on efforts toward enhancing the learners' performance in all key stages of the K to 12 Basic Education Curriculum (BEC), which is low proficient (25-49) as per Rx ADOBE assessment report.
- 4. This Office directs the recalibrated implementation of the Rx ADOBE Learning Recovery and Continuity Plan (LRCP) and its contextualized programs in the field to close learning gaps and ensure a productive and continuous educational journey.
- 5. In adherence to Equal Opportunity Policy (EOP), inclusive and fair treatment are accorded to all participants regardless of age, gender and sexual orientation, disability, religion, and ethnicity.
- 6. Immediate dissemination of this Memorandum to all concerned is desired.
