- 2. The District Selection Committee, headed by the designated Public Schools District Supervisor (PSDS) shall be responsible for posting the notice in not less than three (3) conspicuous places within and outside the District Central School premises from **November 11 December 02, 2022**. After which, he/she shall accept letters of intent with supporting documents from interested applicants.
- 3. Interested applicants from other schools in this division may submit their letter of intent to the concerned School Heads. Deadline for submission of applications will be on or before 5:00 pm of **December 05, 2022**.
- 4. All applications shall be forwarded to the **District Central School** where the school with the vacancy belongs. The District Selection Committee, headed by the designated Public Schools District Supervisor (PSDS) will then conduct a preliminary evaluation of applicant documents on **December 06, 2022** which shall generate a District Selection Line-up to be certified by PSDS.

- 7. District Ranking Results shall be submitted to the Division Office on December 28, 2022.
- 8. Venue and date of Final Evaluation of documents by the Division Human Resource Merit Promotion and Selection Board (HRMPSB) together with the Chairman of District Selection Committee will be announced in a separate memorandum.
- 9. MEC Order No. 10, s. 1979 (Implementing Rules and Regulation for the System of Career Progression for Public School Teachers) will be used as basis for document evaluation and interview.
