- 1. In the interest of public health, please be informed that the COVID-19 vaccination has extended to the pediatric group aged 5-11 years old.
- 2. All teaching and non-teaching personnel shall initiate and support the vaccination of learners ages 5-11 years old through information dissemination and demand generation in all schools in coordination with the Local Government Units and the Department of Health as per Regional Memorandum No. 84, s. 2022.
- 3. Strengthened efforts must be done by all teaching, non-teaching personnel, together with the DRRM Coordinators and school health personnel, to accelerate the full vaccination of all learners in all DepEd schools as a preparedness measure to full resumption of face-to-face learning modality. Advocacy and communication must be led by the heads of schools.
