This ensures that the modules/activity sheets provided to the learners are error-free in terms of content, format, language, layout, and design.
- 3. The school heads shall submit the error-watch report effective 3rd quarter of SY 2021-2022 through this email: gemma.pajayon@deped.gov.ph. The submission will be within 15 days after the end of every quarter. Enclosed is the template of the said report.
- 4. All Public Schools District Supervisors and Education Program Supervisors are directed to monitor school-based practices and strategies on the reproduction and
