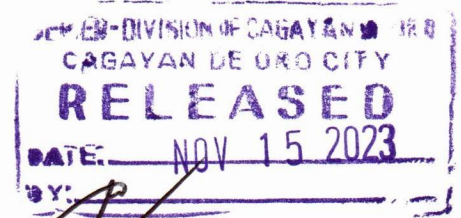

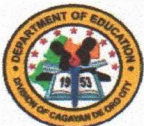

1. As we continually strive to enhance the effectiveness of our educational assessments, a District Reading Validation Team will be established. This team will be chaired by the Public Schools District Supervisor, co-chaired by the Education Program Supervisor, and will include all school heads as its members. The validation process will commence on November 14 and is expected to conclude by January 19, 2023.
2. The primary objective of this team is to conduct a comprehensive validation of the Diagnostic Reading Test across all public elementary and secondary schools within our division. The Reading Validators shall familiarize themselves with the Diagnostic Reading Test materials, the procedure, and protocols. The Public Schools District Supervisors and the partner Education Program Supervisors, shall collect and analyze the test data, and report findings, provide technical assistance and address any issues that may arise during the validation process.
3. Your cooperation in this matter is crucial to the success of the Diagnostic Reading Test Validation. The insights gained from this process will contribute significantly to the improvement of our educational assessments and, eventually, the quality of education we provide to our students.
