1. The Department of Education (DepEd) Regional Office X, through the Curriculum and Learning Management Division (CLMD), will conduct an **Interfacing among the Region X Arling Panlipunan Supervisors and School Heads Implementing Comprehensive Sexuality Education (CSE) and Yearend Program Implementation Review** at NEAP X, Lapasan, Cagayan de Oro City, on November 27-28.
