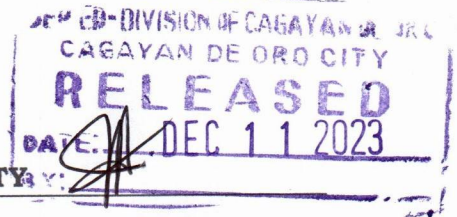

INVITATION TO THE 2023 PRIVATE EDUCATION NATIONAL CONFERENCE

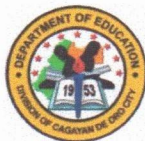

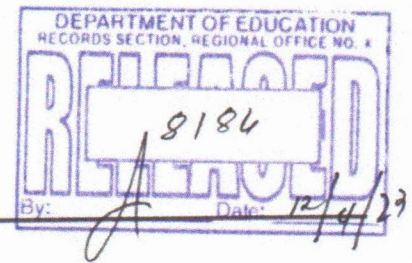


