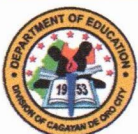



Additionally, the writers will receive an honorarium, charged to the 2023 PFSS Fund, for the professional services they will render during the writeshop.
